Safe & Considerate Riding Agreement:

Riding safely and considerately is vital to the safety and enjoyment for all riders. The future of cycling events in Colorado depends on your cooperation in following safe cycling practices. I agree to the following:

- Wear a helmet at all times while riding.
- Always carry personal identification.
- Obey all traffic regulations, signs and lights.
- Ride as far to the right side of the road as practicable.
- Ride single file except to pass when possible.

Release and Waiver Statement:
